






Research by Discipline

New Bravo Restrictions in the EU

The European Union (EU) has imposed new regulations that will reduce the Bravo® (Chlorothalonil) for cranberries from 2 ppm to 0.01 ppm for exporting countries ...


- Most EU fruit comes from MA and NJ.
- Does not affect 2014 crop.
- 2015 Likely affect use of Bravo



What happens now?

- First apply for a new Import Tolerance for Bravo on cranberry.
 - Expedited review?
 - Temporary tolerance in the meantime?





Actively pursuing several options

- USDA trade negotiations
- US-EPA connections with EU regulators
- Enlisting Syngenta contacts in EU
- Cranberry importers and their trade associations.






Fruit Rot Control for 2015

- Bravo restrictions also in Canada
- Only affects fruit going to EU. All other markets no change.
- Except for Proline, fruit rot fungicides pose no MRL risk.









Cranberry Fruit Rot Fungicides

US, Canadian and EU MRLs (ppm)

Chemical	Trade	US	Can	EU
Abound	Azoxystrobin	0.5	0.5	0.5
Bravo	Chlorothalonil	5	2	0.01
Indar	Fenbuconazole	0.5	0.5	1
Mancozeb	Mancozeb	5	5	5
Proline	Prothioconazole	0.2	0.2	0.02*



^{*} July 2015 – Final Codex of 0.15 ppm -> EU Final in July 2016.
